
When output enable (OE) is at High level, the switch is on; when at Low level, the switch is off.


All inputs are equipped with protector circuits to protect the device from static discharge.

Pin Assignment (top view)










AC Waveform




Figure 2 t_{pLH} , t_{pHL}






Figure 3 t_{pLZ} , t_{pHZ} , t_{pZL} , t_{pZH}
