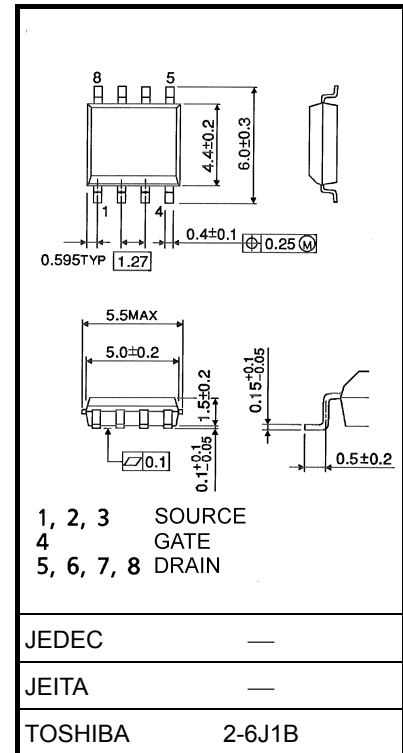

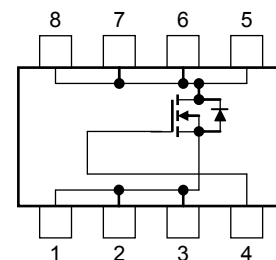

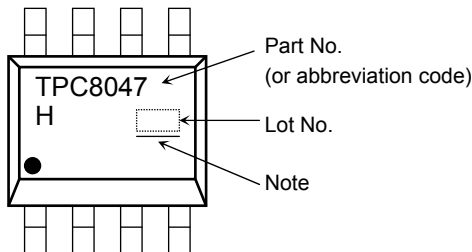
Circuit Configuration
