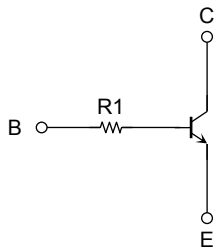

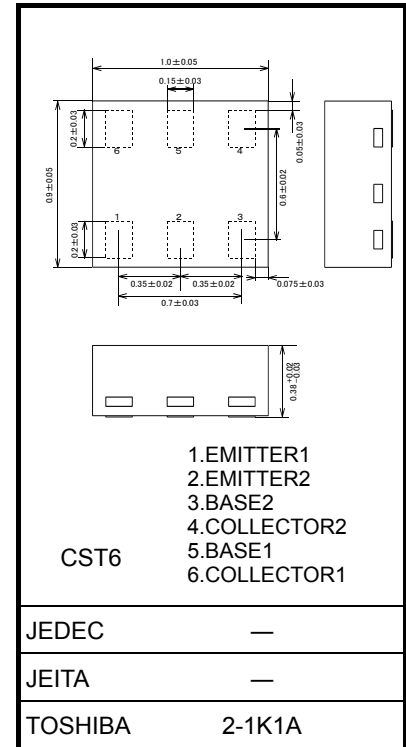
Switching, Inverter Circuit, Interface Circuit and Driver Circuit Applications

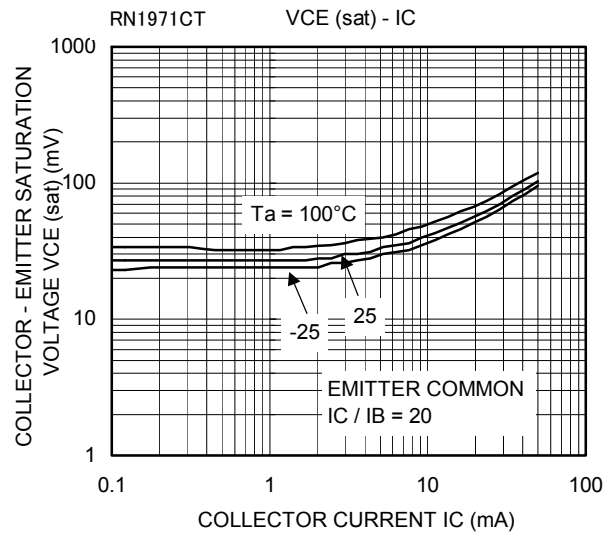
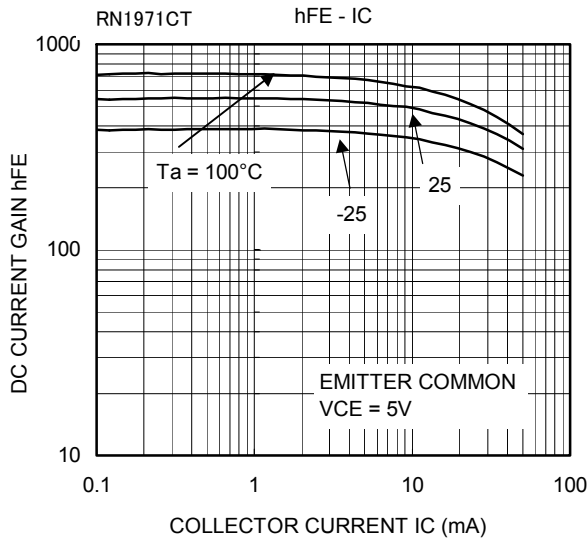
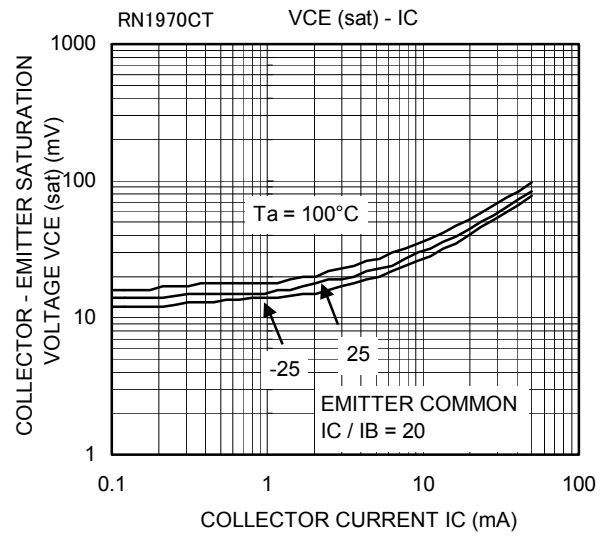
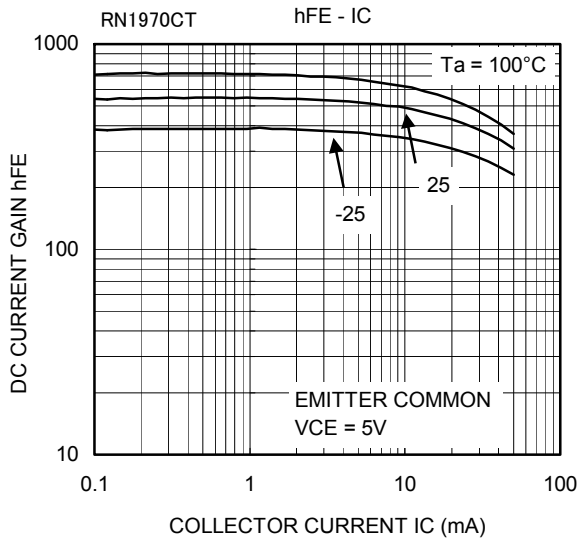
Equivalent Circuit (top view)



