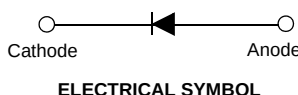

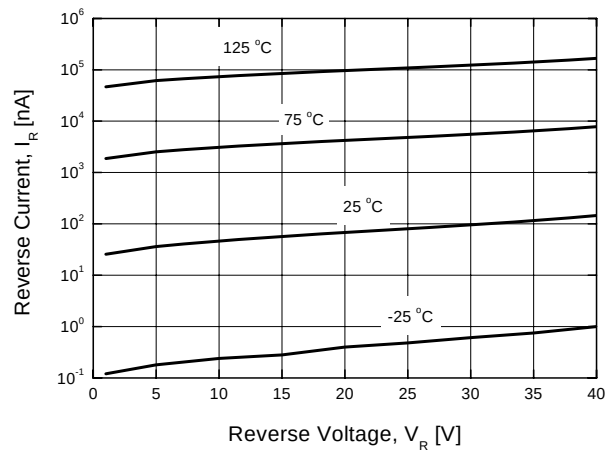

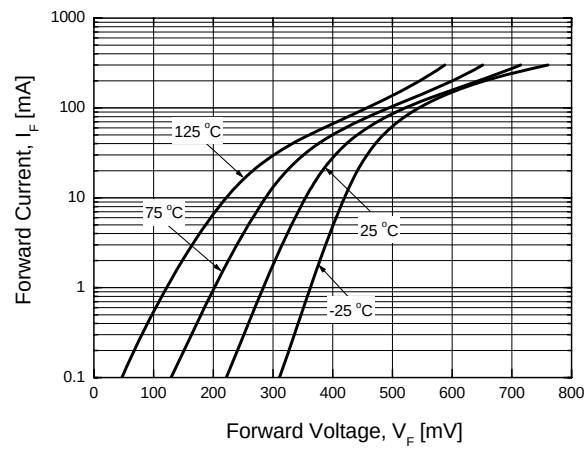

Reverse Current vs Reverse Voltage

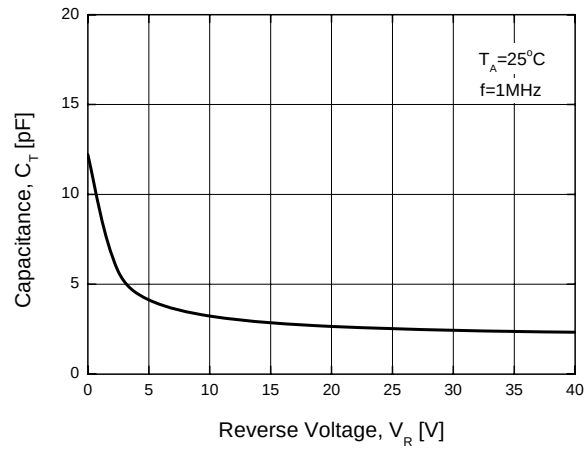


Forward Voltage vs Forward Current

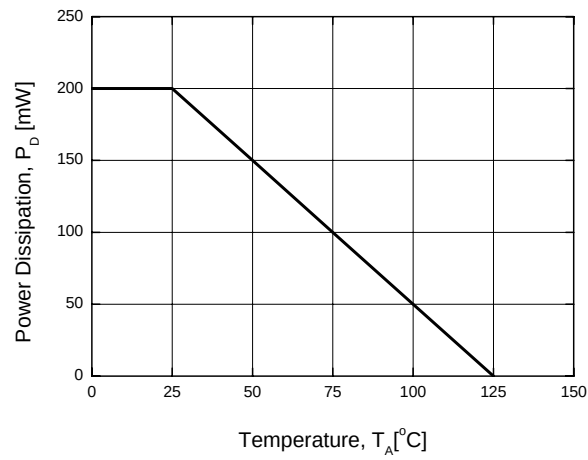

Total Capacitance

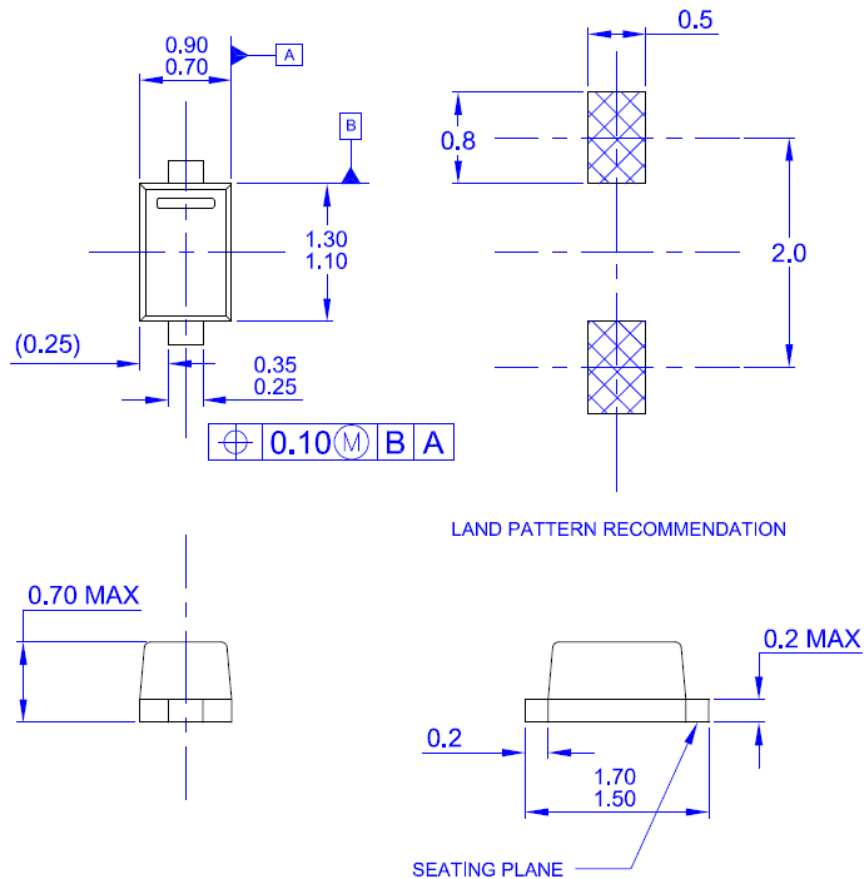


Power Derating Curve
