



Figure 2. DC current Gain






Figure 3. V<sub>CE</sub>(sat) vs. I<sub>B</sub> Characteristics




Figure 4. Collector-Emitter Saturation Voltage




Figure 5. Base-Emitter On Voltage




Figure 6. Forward Bias Safe Operating Area

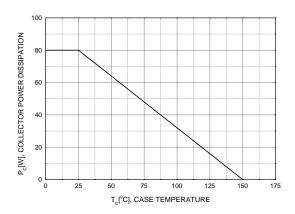



Figure 7. Power Derating
