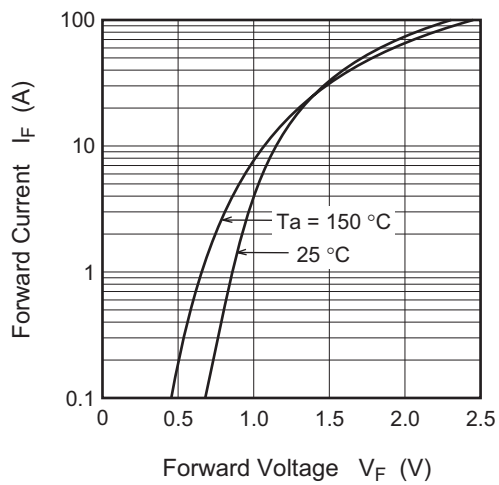

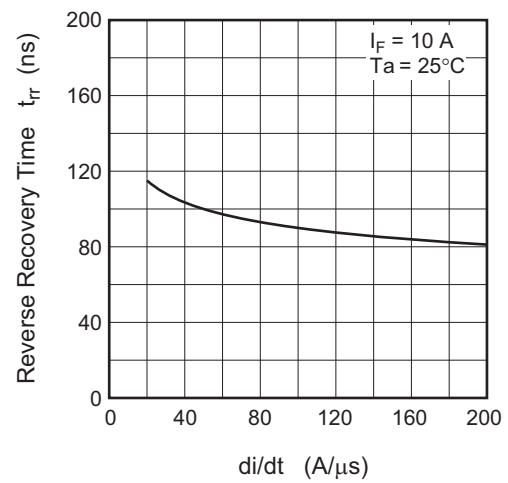

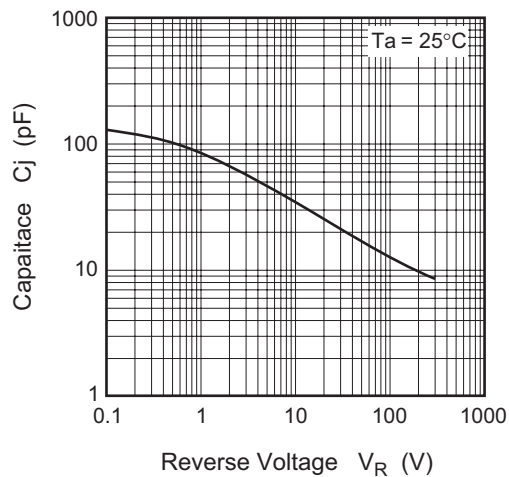
Forward Current vs. Forward Voltage (Typical)



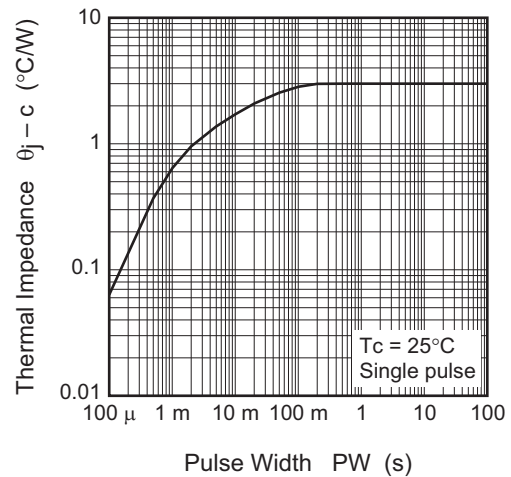
Reverse Recovery Time vs. di/dt (Typical)
