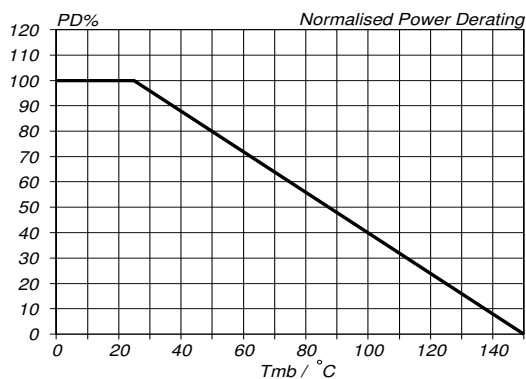


Fig. 7. Normalised power dissipation.
 $PD\% = 100 \cdot PD / PD_{25^\circ C} = f(T_{mb})$

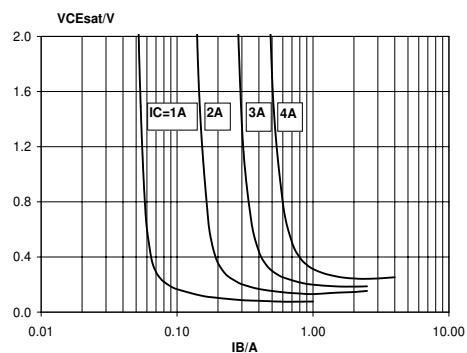


Fig. 10. Collector-Emitter saturation voltage.
 Solid lines = typ values, $V_{CEsat} = f(I_B)$; $T_j = 25^\circ C$.

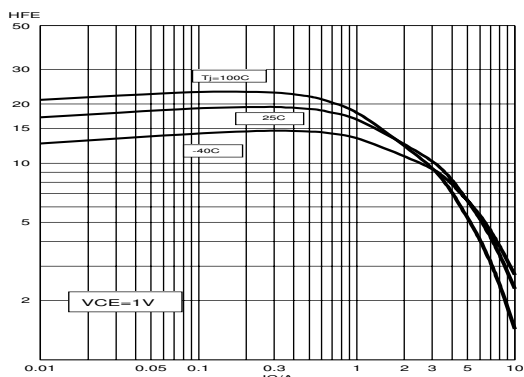


Fig. 8. Typical DC current gain. $h_{FE} = f(I_C)$
 parameter V_{CE}

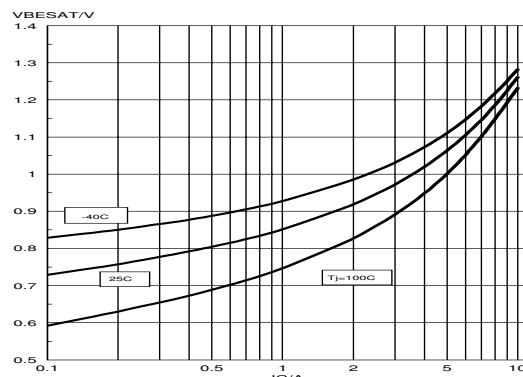


Fig. 11. Base-Emitter saturation voltage.
 Solid lines = typ values, $V_{BEsat} = f(I_C)$; at $I_C/I_B = 4$.

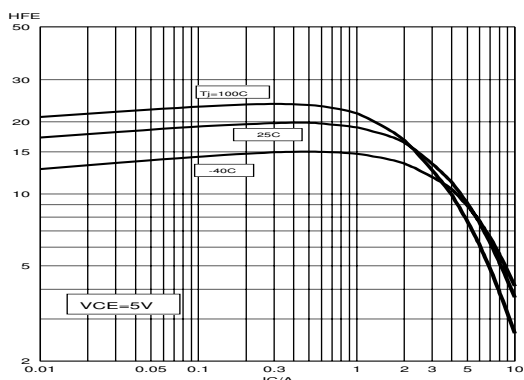


Fig. 9. Typical DC current gain. $h_{FE} = f(I_C)$
 parameter V_{CE}

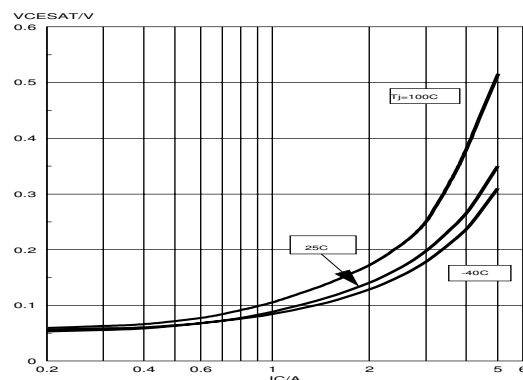


Fig. 12. Collector-Emitter saturation voltage.

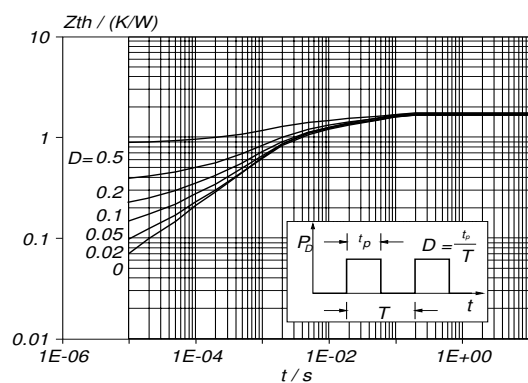


Fig. 13. Transient thermal impedance.
 $Z_{th\ j-mb} = f(t)$; parameter $D = t_p/T$

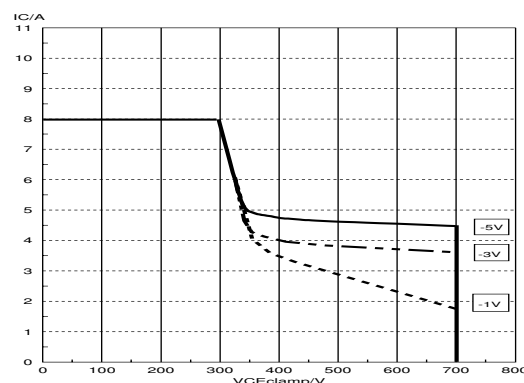


Fig. 15. Reverse bias safe operating area ($T_j < T_{jmax}$)
 for $-V_{BE} = 5V, 3V \text{ \& } 1V$.

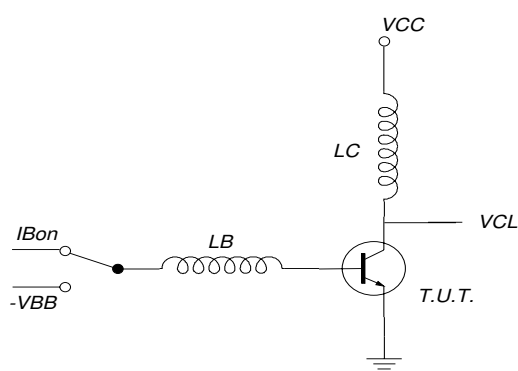


Fig. 14. Test circuit for reverse bias safe operating area.
