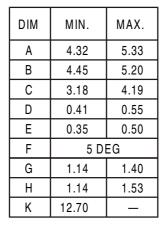

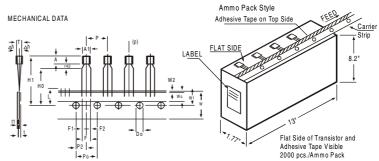


PIN CONFIGURATION
