#### 1.1 General description

Dual high-speed switching diode, encapsulated in a very small SOT323 (SC-70) Surface-Mounted Device (SMD) plastic package.

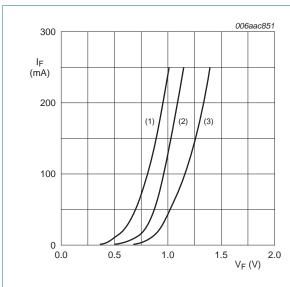

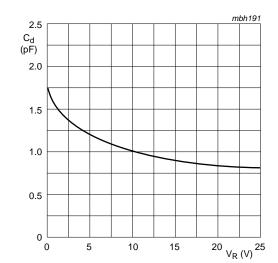

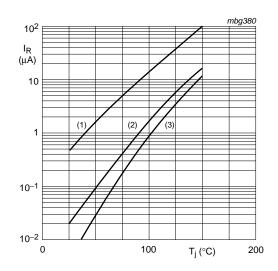

Fig 1. Forward current as a function of forward voltage



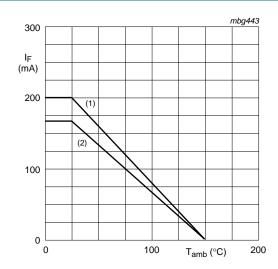
 $f = 1 \text{ MHz}; T_{amb} = 25 \degree C$

Fig 2. Reverse current as a function of junction temperature



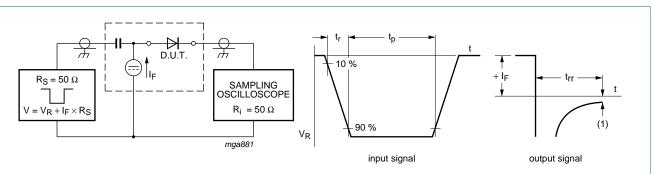
FR4 PCB, standard footprint

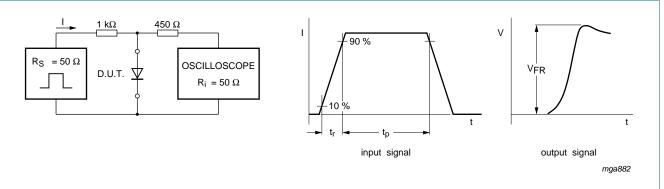

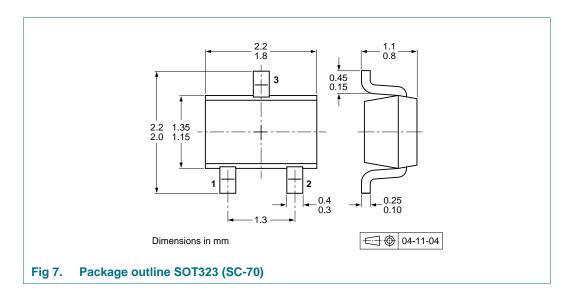
Fig 6. Forward recovery voltage test circuit and waveforms

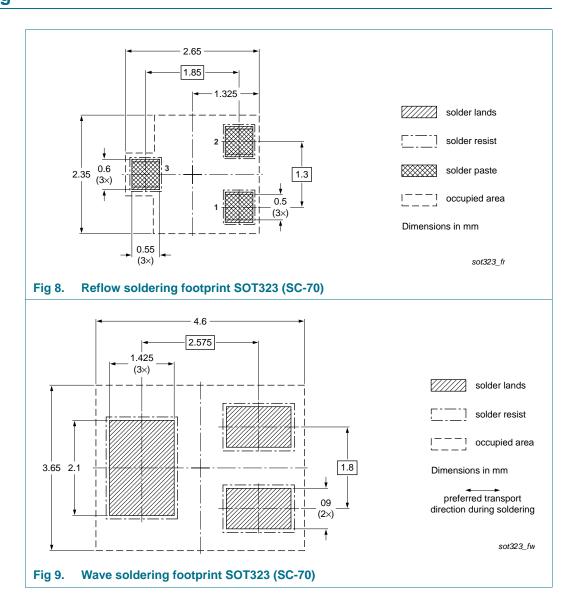
