





Fig 3. Per transistor: Transient thermal impedance from junction to ambient as a function of pulse duration for PUMH15 (SOT363); typical values





Fig 4. DC current gain as a function of collector current; typical values





Fig 5. Collector-emitter saturation voltage as a function of collector current; typical values





Fig 6. On-state input voltage as a function of collector current; typical values





Fig 7. Off-state input voltage as a function of collector current; typical values






