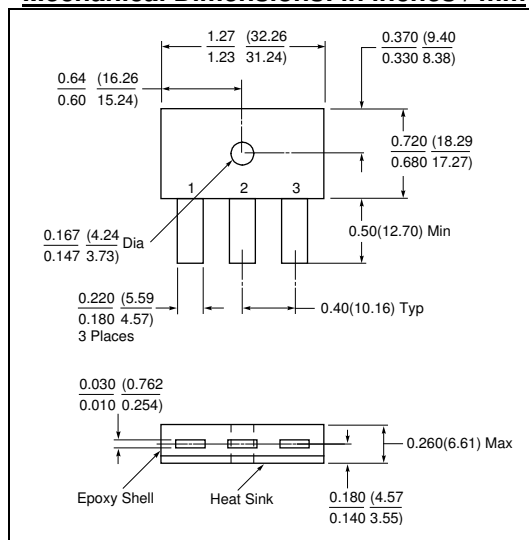

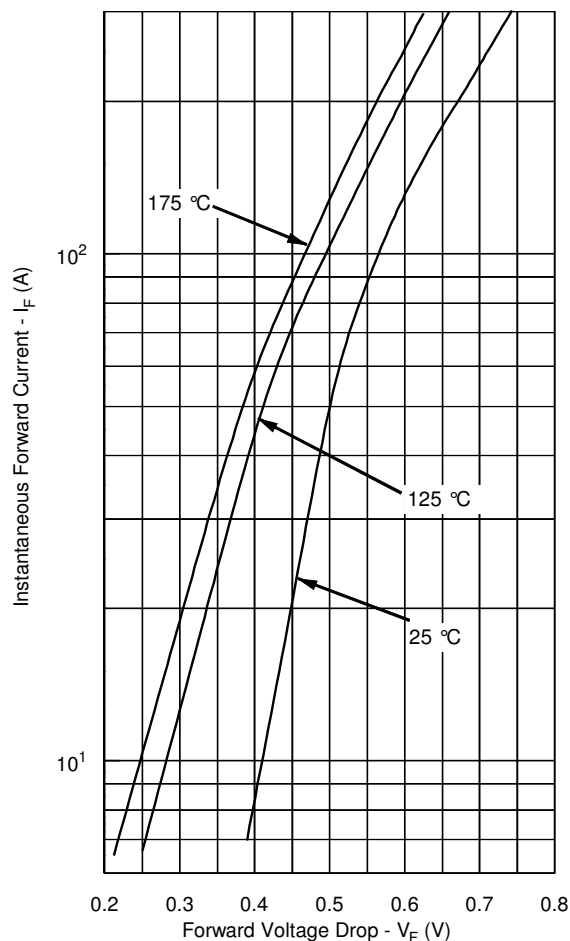

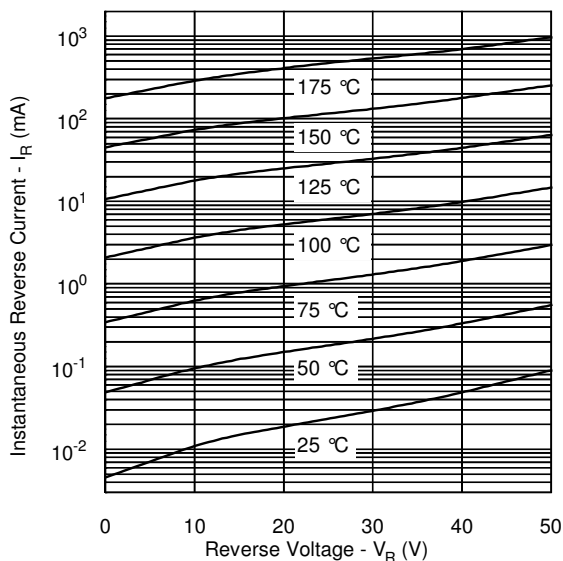
Mechanical Dimensions: in inches / mm



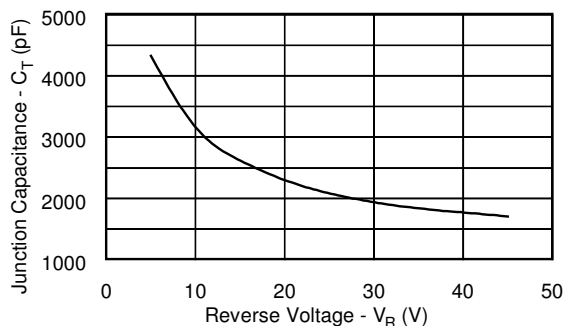
Typical Forward Characteristics
