DESCRIPTION

The **I-160** from IOTA Engineering is a UL Listed fluorescent emergency ballast that allows the same fixture to be used for both normal and emergency operation. In the event of a power failure, the **I-160** switches to the emergency mode and operates **one or two** of the existing lamps for **90 minutes**. The unit contains a battery, charger, and inverter circuit in a single can and is provided with 2 feet of 1/2" flex for wiring to the fixture. The unit is designed for mounting in the ceiling grid, and comes integrated with the recess mounting pan for installation. The **I-160** can be used with most **2'-4'** lamps, with an initial output of up to **3000 lumens** for one or two lamps, and **utilizes AC output to ensure compatibility with new lamp technologies**. The unit features lamp selector leads for optimizing light output for designated lamp types. The **I-160** is suitable for use in damp locations.

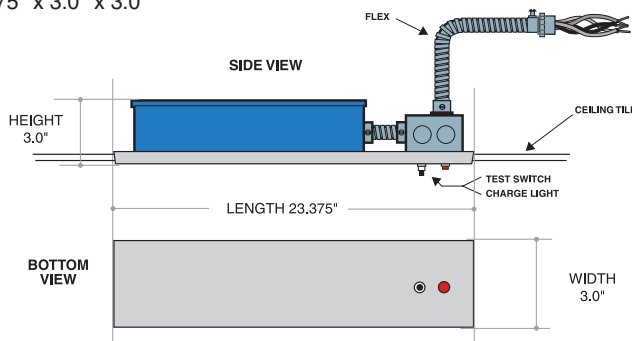

I-160R SAMPLE SPECIFICATION

Emergency lighting shall be provided by using a standard fluorescent fixture equipped with an **IOTA I-160R** fluorescent emergency battery pack. The **I-160R** shall consist of a high temperature, maintenance-free nickel cadmium battery, charger board and an electronic circuit enclosed in a 16.375" x 3.0" x 3.0" vandal-resistant painted steel case, and equipped with a recess mounting pan for installation in the ceiling grid. A long-life LED charge indicator light and test switch shall be included. The fluorescent EM pack shall operate one 17w-59w T8, 24w-95w T5 (2'-4'), one 59w T8 (8'), (1) 25W-50W long compact, or 18w-70w 4-pin compact, or two 17w (2') T8 or two 18W-26W 4-pin compact lamps. The **I-160R** shall provide reduced illumination for a minimum of 90 minutes in the emergency mode with a total initial output of 3000 lumens, and **will operate the lamp with AC output**. The unit will feature selectable lamp leads for optimizing light output for the designated lamp type. The **I-160R** shall have 4.5 watts of input power and a battery capacity of 48 watt hours. The **I-160R** is UL Listed and meets or exceeds all NEC and Life Safety Code Emergency Lighting Requirements, and is rated for use in damp locations. The **I-160R** is warranted for a full five (5) years from the date of purchase.
