




R<sub>DS(on)</sub> vs. V<sub>GS</sub> vs. Temperature



**Threshold Voltage** 



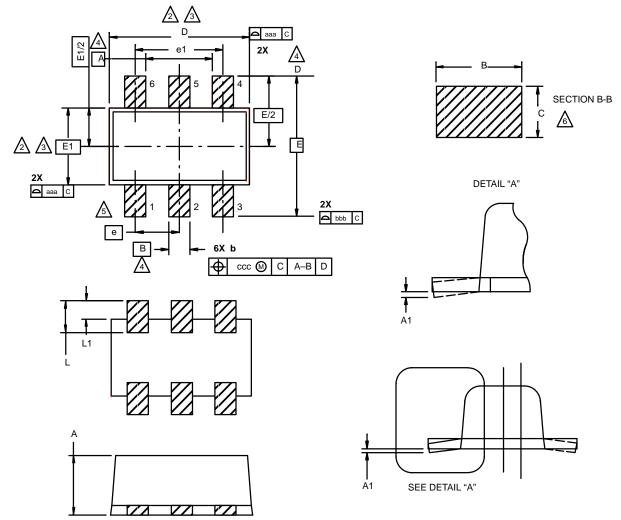


Normalized Thermal Transient Impedance, Junction-to-Ambient

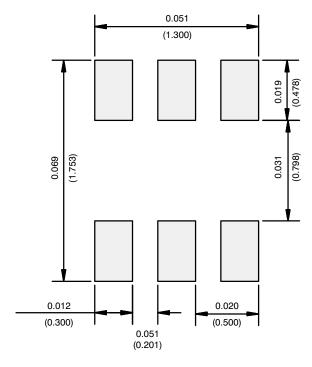
