


On-Resistance vs. Drain Current and Gate Voltage






**Transfer Characteristics**





On-Resistance vs. Junction Temperature








### Source-Drain Diode Forward Voltage









Threshold Voltage


Single Pulse Power





### Normalized Thermal Transient Impedance, Junction-to-Ambient



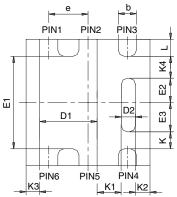

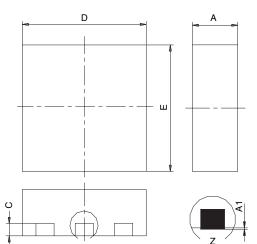
