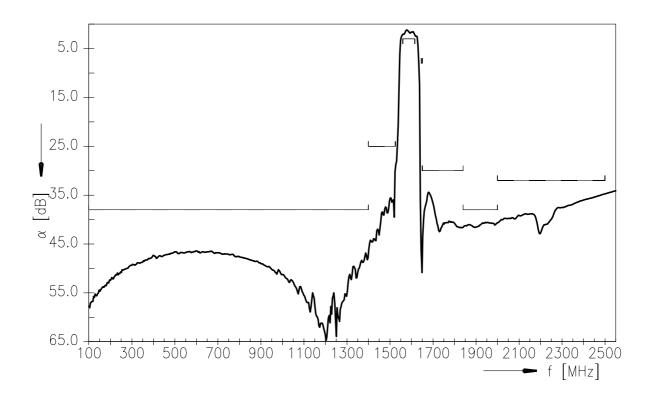

## Transfer function (wideband)



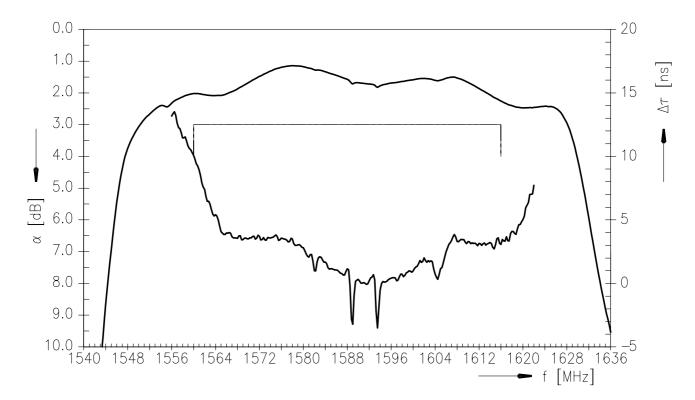
